Please note that the government's Student Finance Office (SFO) will accept information supported by the documentary proof provided. **If documentary proofs provided are NOT substantiated** (e.g. self-written income statement unexplained prolonged unemployment), **SFO may need to make adjustments and apply benchmark figures** on the basis of statistical information provided by the relevant government departments, such as the Census and Statistics Department and the Rating and Valuation Department, etc. to assess the income and/or net value of assets concerned. SFO may also apply projected figures in the family income in the assessment if necessary.
- (3) Maximum grant levels may be adjusted upwards for students required to take part in **overseas compulsory field trips** in 2024/25. Applications for such will be submitted to the SFO via respective Department/School and Student Affairs Office (SAO). Final approval is subject to the confirmation of the SFO.
